Comments: Concerns and suggested changes to the Heber Wild Horse Management Proposal:

Tables 4 & 5 Horse Survey: The last horse number survey was conducted four years ago in 2017, I assume due to lack of funds. As a result of fires and the severe drought Arizona has experienced during the last four years, significant changes to the wild horse population have most likely occurred.

Table 10 Total Available Forage: The forage availability is based upon only three data points (2007, 2008 & 2018) with a ten year spread. During this time, fires and drought conditions undoubtedly changed forage availability. Three data points over an eleven year period does not provide a significantly accurate average.

All of the following are suggested changes to the verbiage in the proposal. In order to achieve consistency, efficiency and increase probability of success, actions specified throughout the proposal need to be focused without possibility of deviation from the desired outcome. The frequent use of the word "should" throughout the specified actions throughout the proposal provide possible options that could lead to undesirable outcomes. I suggest that the following changes be made:
