Greetings to all from the Planning Team--With the publication on August 25, 2021 of the Notice of Intent to revise the Manti-La Sal Land and Resource Management Plan (aka Forest Plan), we would like to announce the final sixty-day period for your input regarding the draft proposal that has been shared online since last October.

Although we originally intended to visit area communities in person to discuss the proposal and your concerns or ideas, recent changes in the pandemic are returning us all to a virtual platform for the safety of local communities and our staff. Anyone who has not been with us previously or anyone who would like a refresher of all the resources and information already at the planning website, Manti-La Sal Forest Planning, is invited to join us for an overview and introduction from 6-7:30 pm on September 15th.

During the following week, we will also offer two topical virtual sessions with staff specialists. On September 21st from 6-7:30 pm, we'll talk about Ecological topics-wildlife; botany; hydrology; fire/fuels management; and special designations: wilderness, wild & scenic rivers, research natural areas, botanical areas. On September 22nd, from 10:00 to 11:30, Socio-economic topics will be on deck--recreation/scenery; range management; timber; minerals; cultural resources; watershed management (including Moab geographic area and municipal watersheds)
