Comments: As a climber of over 10 years, I feel compelled to address the proposal to outlaw bolting in Wilderness Areas. While I deeply respect the need for thoughtful management and regulation, I believe that an outright ban on fixed protection is misguided and could have detrimental consequences for climbers, the environment, and safety.
