## Dear Forest Service,

It seems unreasonable for federal agencies to introduce new guidance policies that outright prohibit Wilderness climbing anchors across the country, especially when they have historically allowed, managed, and authorized fixed anchors for decades. The climbing community has actively engaged in responsible practices, contributing to the preservation of our natural spaces and the enjoyment of climbers without compromising the integrity of Wilderness areas.

Prohibiting fixed anchors introduces safety concerns by creating unnecessary obstacles to their regular maintenance, a responsibility diligently undertaken by the climbing community. Critical safety decisions often require real-time responses, and any authorization process should not impede those decisions. Maintenance procedures should be managed to incentivize safe anchor replacement and prevent the inadvertent removal of climbing routes.

The prohibition of fixed anchors also obstructs the appropriate exploration of Wilderness areas. Climbers should be granted the flexibility to make in-the-moment decisions necessary when navigating complex vertical terrain. Restricting this ability hampers the spirit of exploration that defines the climbing experience in these natural landscapes.

Additionally, prohibiting fixed anchors jeopardizes America's rich climbing legacy and could erase some of the world's greatest climbing achievements. Climbing management policies must prioritize the protection of existing routes from removal, ensuring the preservation of our climbing history and the continuation of this cherished outdoor tradition.

I urge you to reconsider and revise the current policy on fixed anchors in Wilderness areas. Engaging in collaborative discussions with representatives from the climbing community will help establish a balanced approach that ensures the safety of climbers, preserves the unique character of Wilderness areas, and safeguards America's climbing heritage.
