The publication of a legal notice in the Bradford Era begins a 30-day comment period. I expect the legal notice to publish on October 4, 2024. If you wish to confirm this publication date or receive a copy of the legal notice, please contact me.

Also, I extend an invitation to anyone interested in the project to contact me if you would like to meet with our staff to look at stands in the project area, discuss the rationale for the project etc... We have an excellent staff of silviculturists and foresters (also wildlife biologists, recreation specialists etc...) that would be happy to take you through the project area and answer any questions on the project.

Some of the comments on the project proposal expressed concern with logging in close proximity to the Morrison Trail and the North Country National Scenic Trail (NCNST). I have discussed this topic in the Environmental Assessment but would be happy to discuss further. In this project area, we have had previous timber activity around both trails in the past. Some years ago, we started placing a minimum 100' no cut buffer on both sides of the NCNST. Timber buffers around the Morrison Trail have varied in the past. For this project we are placing a 100' no cut buffer on both the NCNST and the Morrison Trail. Again, my staff is available for any questions or address additional concerns.
