Pes La is the center of the Black Hills and is a Sacred Site for the Lakota Nation, and the laws of the United States Government they are bound to by Treaty, the Lands within the Black Hills belong to the Lakota People to this day, and they want Pes La and the Black Hills to be protected forever, in perpetuity. I oppose the Rockford Mineral exploratory drilling project, and their proposal. Mining in the Black Hills and up at Pes Ia, is where the Springs flow up and out of the Earth, and feed into the creeks that feed into Deerfield Lake and all the creeks that derive fro the Springs there, directly flow into the watershed that feeds into the Headwaters and rivers that give Life and provide fresh water and clean drinking water, to All areas in the Black Hills as well as for Rapid City and surrounding regions. I demand that the Forest Service reject their proposal and deny their permit. It would lead to a disaster, puncturing the Aquifers that lay beneath Pes La and it would permanently destroy the Water Quality and pollute and poison it and All Life that depends upon it, which is all aquatic Life, migrating birds, animals and wildlife as well as harm everything including People.
