We have lived in Driggs and skied for years at Grand Targhee. We hike the trails in and around Grand Targhee, and especially the valley that Grand Targhee wishes to develop. We are so fortunate to have these pristine lands available for wildlife, wildflowers, streams, and undisturbed terrain in around this area. Grand Targhee is special because it is a smaller ski resort and is still a very natural area. Grand Targhee has done a good job in making a great place to be, by not being too big and overdeveloped.

Please do not approve of this expansion of Grand Targhee!

We already have bike trails at Targhee and the Big Holes. We already have ski, cross country ski and snowshoe areas that are easily accessible. We already have a large resort in Jackson Hole. Grand Targhee should not be allowed to develop further into the south facing bowl. The wildlife is already under intense pressure.
