It is the understanding of the community members that make up OurCibolaForest that the deadline for the inventory phase of the Wilderness discussion has been extended (without current deadline) until revised maps are generated and published and given opportunity for public response.

The attached data file contains community member generated content as well as content generated from the 200 plus attendees of the Wilderness Prevention Forum held in October 2014. This data contains:
