Comments: Dear United States Secretary of Agriculture George Ervin "Sonny" Perdue III,

On behalf of Greenpeace USA and millions of our members we strongly oppose the proposed exemption to the Roadless Rule in the Tongass as presented in Rulemaking #54511.

Almost 100,000 Greenpeace supporters have taken action in opposition to Rulemaking #54511 (84 FR 55522): 96, 247 individuals have signed a general petition and over 9,146 have submitted personalized comments.

The Tongass National Forest is of global importance, and opening it to logging or mining has permanent, detrimental consequences. This latest attack on wildlife and forests has been made under the guise that this will boost Alaska's economy, when only 1% comes from the logging industry, and isn't worth the permanent consequences.

The loss of old-growth forest will intensify the effects of climate change.

9,146 of the attached submissions included Form Plus letters. Unique substantive formal comment (beyond that submitted in the master form (above) is below. Substantive formal comment is defined as "within the scope of the proposal, have a direct relationship to the proposal, and include supporting reasons for the responsible official to consider" (36 CFR 219.62).

This forest has a much more and longer lasting value as a tourist attraction than an oil field.

This action indicates a profound lack of knowledge about old growth forests and forests in general. The trees one sees when looking at a forest is a mere 5% of what is actually there. There are hundreds, even thousands, of

animals and complementary plants dependent on an intact forest. Replanting clearcut forest is a start, but it won't replace a five hundred-year-old forest for, by definition, five hundred years. T

There will be a short-term net economic boost but unless investments are made to correct the damage and provide a long term sustainable economy, then this step will benefit a few but hurt a much larger number. Decisions should be made for the good of the majority and not for the benefit of a minority.
